

# The Resolutions Committee has proposed the following change to the By-Laws:

The following change to By-Law Article IV, Membership, Section 3B Emeritus Membership Status: Changes in **[BOLD]** 

Section 3B. Emeritus Membership Status: Any member meeting the following requirements may be proposed for Emeritus status by the Membership Committee. The member must:

- 1. be at least 60 **[55]** years of age.
- 2. be retired from full-time forensic work
- 3. have been a full dues paying member in good standing of the Association for a minimum of five **[ten]** years.

Members holding Emeritus Status shall retain all rights and privileges of members, but shall be excused from all dues and assessments. They shall be eligible to continue their emeritus status and receive publications free of charge on an annual basis upon request to the membership chairman. Emeritus status shall be conferred by recommendation of the membership committee with the approval of 3/4 of the voting membership at the annual business meeting.

Discussion on Corporate sponsorships, changes in costs and Booklet Ads, targeting sponsors and latitude of exhibits committee. Discussion of vendor deadlines for payment and inclusion in program booklet and booth signs per language in the contract. Discussion of vendor level sponsorship vs. sponsoring all or part of an event, break, etc. Addition of Luncheon sponsor and give-a-ways. # In Memory of Mabel Y. Hores

Senior Forensic Scientist Criminalistics Unit, NJSP Central Lab



After a two-year battle with cancer, Mabel Y. Hores passed away this March. After graduating from Trenton State College, Ewing, NJ in 1979, Mabel began her Forensic career with the Equine Laboratory at the Meadowlands Racetrack. A year later she transferred to the North Regional Laboratory in Little Falls and was assigned to the Drug Unit. After several years as a certified Drug Examiner, Mabel transferred to the Trace Evidence Section of the laboratory. Mabel quickly became one of the most respected trace examiners in our laboratory system due to her conscientious work ethic and dedication to trace evidence examinations. In 1991, Mabel received the Fathi Rafla Award. This honor is given to scientists in the NJSP Laboratory System who are recognized for their Meritorious Service in the field of Forensic Science. In 1998, when consolidation of services was implemented, Mabel transferred to the Central Laboratory in Sierra Park where she utilized her abilities to improve the Trace Evidence Section. Mabel became the first fully certified Criminalistics Scientist in the Laboratory system. She was cross-trained in both Biochemistry and Trace Evidence analysis.

Numerous friends, family, and colleagues in the Forensic Field will miss Mabel. She has left a void that will be difficult to fill not only in the Criminalistics Unit and our Laboratory System but also in our hearts.

# In Memory of W. Reid Lindsay

Forensic Photographer Westchester County Forensic Laboratory

W. Reid Lindsay passed away on June 27, 2004 at Vassar Brothers Medical Center, Poughkeepsie. Reid studied at the State University of New York at New Paltz. # FORENSIC BIOLOGY TECHNICAL SESSION

"ASTRID in Texas"

Donald I. Promish, MS

This presentation shows how ASTRID (An STR IDentifier) and DEME were used to help solve a case that appeared to be the "debut" of a serial killer in Sheer Bluff, Texas. At the beginning of the investigation, when there was no suspect, ASTRID calculated the probability that the culprit was a member of each reference population in the case. Sheer Bluff's main populations are: USA Caucasians, African-Americans, and South Western Hispanics. ASTRID's results helped set priorities in the search for a suspect among these populations. First, two possible culprits had to be eliminated. One was the victim's lover; he was cleared easily, on both DNA and other grounds. The other," the third man," was cleared only by thorough research and analysis in which DEME played a part. Next, both ASTRID and DEME calculated the probability that the single remaining culprit was the suspect, given a match between the culprit's profile and the (as-yet- unfound) suspect's. The DNA evidence in this case was so strong that neither ASTRID nor DEME needed a "probable cause" prior probability (0.50); they used 0.001, the inverse of Sheer Bluff's total population, in their calculations. ASTRID calculated without regard to substructure; DEME took substructure into account. Their results agreed to eleven decimal places.

# Are We Ready to Confront Weapons of Mass Destruction?

Forensic scientists are playing a critical new role in the Post-September 11<sup>th</sup> World. The tools, technology, and expertise we offer is being called upon with increasing urgency: Whereas previously a concealed compartment within an automobile usually meant a controlled substance was involved, today it could realistically implicate the presence of a WMD — Weapon of Mass Destruction — including advanced weaponry or agents of chemical or biological terrorism. As Forensic Scientists, we could find ourselves as the first and only investigators in a suspected vehicle or dwelling, *unaware of where weapons might be hidden or what kinds of weaponry might be encountered*. The question is: Are we prepared? Hear – and learn – from the front-line people who face these situations daily in the fight against terrorism, and gain invaluable insights for our newest job requirements.

During his military career, he implemented and managed several security, antiterrorism, and law enforcement programs in the United States, Europe, Northern Africa, Northern Iraq and The Former Republic of Yugoslavia.

He is a graduate of the FBI Academy's Law Enforcement Executive Development Program, Quantico Virginia, the General Services Administration's, Senior Executive Development Program, Texas A & M University and the Security Management Institute's Professional Security Management Program from John Jay College of Criminal Justice.

Ray has received many awards and commendations throughout his 30year career with the Federal Government including the General Services Administrator's Award for Valor, and the Regional Administrator's Commendable Service Award for Valor for his actions during and after the 9-11 Terrorist attack in New York City. He is a member of The Honor Legion of the Police Departments of the State New Jersey and of the Police Department of the City of New York.







# Nabbed: Kids Get Caught Up in Forensic Science (With Your Help, That Is)

The murder in the park was headline news. The police commissioner was being pressured from all sides to give the city an answer, some reassurance that this wasn't another in a long string of grisly killings by someone the paper had dubbed "the hillside killer." Detectives were closing in, waiting for one more piece of evidence from the lab—and then the DNA results came through! Police suspicions were confirmed, and an arrest was made! The city was safe! The prime-time show came to a close.

Exciting stuff—and very popular nowadays. Television shows and bestsellers paint a fast-paced picture of solving crimes with more than a police-issued gun and a quick mind. High-technology tools have definitely become a part of today's police work. Shows such as *CSI: Miami* and *COPS* get high ratings from viewers, adults and kids alike.

It's just too bad that those shows and books don't paint a realistic picture—DNA results back from the lab in 24 hours? Fingerprint analysis done in an afternoon? Not quite.

Now's your chance to help correct such misconceptions. How? Get involved with an ongoing National Science Foundation-funded program called Science on Patrol (SOP).

SOP seeks to increase kids' interest in science. Specifically, it helps youth learn forensic science through collecting and analyzing evidence and solving the crime scenes. Members of the New York City Police Department have gotten involved with the program, developed by the Institute for Schools of the Future (ISOF) and the New York City Police Athletic League (PAL), by setting up crime scenes for middle school students to analyze. The kids have been drawn in and—more important—have begun to learn the role of forensic scientists in solving crimes.



Even if you don't give kids superhuman powers that let them do so in 24 hours, in working with SOP you can help them realize that their interests, scientific knowledge, and skills can help solve crimes.

SOP is designed to promote interest and achievement in science for students from underrepresented communities—particularly girls—by providing youngsters with "crimes" they can solve by applying the scientific processes and skills actually used by crime scene investigators. Here's where you come in: SOP is seeking forensic scientists who are interested in getting involved.

Obviously, forensic scientists are the experts in this scenario. Because of the known accuracy of forensics work, your involvement in SOP will legitimize what the kids are doing and help them understand the reality of this work.

You can help correct the impressions they've gleaned from TV. You can encourage and reinforce their excitement in science and their satisfaction in solving problems.

As a volunteer, you might get involved in any of the following ways:

- •Working in hands-on sessions with students
- •Helping to develop "crime scenes" for investigation
- •Helping to develop other program content
- •Reviewing existing program materials for accuracy and/or to enhance the content
- Participating in an email newsletter
- •Interacting on line with students to answer questions.

"Interacting with role models will help youngsters realize that they might have a future in the field of forensic science or policing," says Bonnie Brownstein, director of SOP and ISOF, a not-for-profit organization charted by the New York state university regions that has operated for 20 years. "We are excited about the potential for collaboration with forensic scientists."

Sessions run for six weeks in after-school sessions at PAL sites. Teams of instructors to date have included a police officer or detective, a teacher, and a PAL representative. Now ISOF and PAL would like to add a forensic scientist to the team. You do not have to be located in the New York City area to volunteer. The amount of time you commit is up to you—from a single contribution to ongoing involvement.

With your involvement, the fascination kids have with solving crimes will increase - without the TV-generated misconceptions and *with* real-life knowledge and techniques.

This is an introductory level course that is not intended for experienced firearm examiners. The two-day hands-on workshop will begin with a day of instruction and lectures from firearm experts, followed by practical application of the lessons. Topics will include the fundamentals of firearm manufacturing, nomenclature, operating principles, interaction with ammunition, scientific laboratory examination and microscopy techniques. Instructors will use replica and cut-away firearms to elucidate the nuances of firearm function, ammunition firing sequence and machine tool operations. After learning the basic principles of firearm examination, attendees will be given a packet containing mock evidence and an evidence report sheet. Participants will examine their unknowns (using measurements and comparisons to knowns) at various workstations and report their findings. The report will then be compared to the known results.

### Workstations will include:

Stereomicroscopes for trace evidence and class characteristics
Calipers and micrometers for measurements of ammunition components
Comparison microscope for sub-class characteristics
Trigger pull measurements
Muzzle-to-target distance determination (shotgun)
Serial number restoration via Magnaflux
Trajectory methods (not an unknown)

This workshop has been designed to provide a comprehensive discussion of modern approaches to the physical and chemical examination of documents produced by inkjet copiers and printer. Documents submitted for forensic examination that have been printed on inkjet printers are becoming much more predominant. With the advent of this technology, there has been tremendous popularity amongst criminals to use inkjet printers and copiers to commit a variety of crimes such as counterfeiting, criminal record keeping, and producing ransom notes or threatening letters. Forensic document examiners can perform a variety of physical and chemical examinations that may help link multiple documents with each other or a suspect printer(s), ascertain if the document is legitimate with respect to date, or determine the make and model of the suspect machine. In addition, some new ideas will be proposed with the intention of providing forensic document examiners insight into the future of inkjet analyses.
