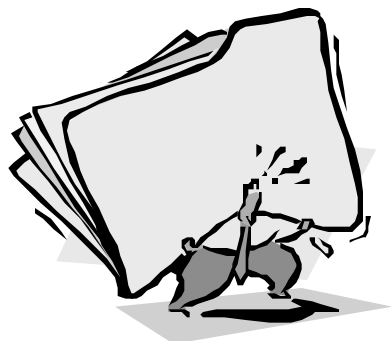

The ABC Board Meeting was held in Boston. The main points of interest are:

- A pilot exam of Fire Debris Specialty will be given this November in Emmetsburg, Maryland at the SWGFEX meeting. The test is being offered for free and records of failure will be expunged (being a pilot test).
- Nominations for Ed Rhodes Rhodes Scholarship Award are due by the end of this calendar year.
- There is no progress on the ABC application for FSAB accreditation.
- ABC is trying to get NIJ grant for subsidizing its offering as well as to bring the test offering to the Internet.
- There will be door prizes from ABC at the NEAFS annual meeting.

-Carl Selavka indicated that it might be possible for NEAFS to get an NIJ grant for its plan to offer training programs over the next 5 years.

IN MEMORIAM

It is with great sadness that the Suffolk County Crime Laboratory announces the passing of Forensic Scientist Joseph Boyer. Joe passed away on September 21, 2002 after suffering a massive heart attack.

Determined to make a life for himself in the United States, Joe fled Romania while under Communist rule in the 1970's and lived in Italy. Joe made a living as a house painter and waiter, all the while saving enough money for his eventual journey to the United States in 1980.

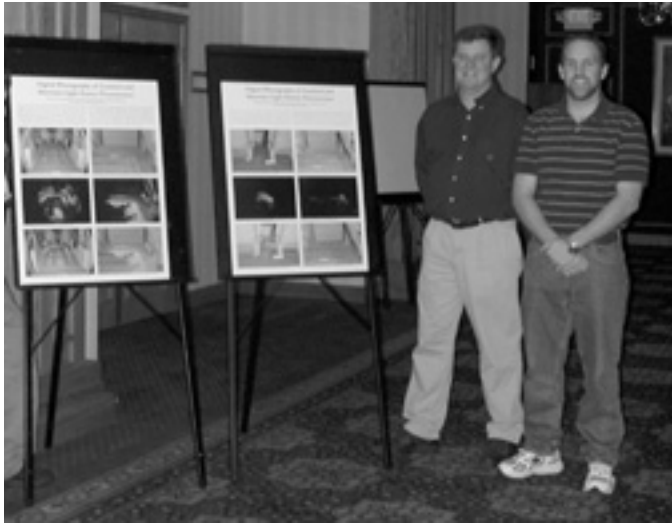

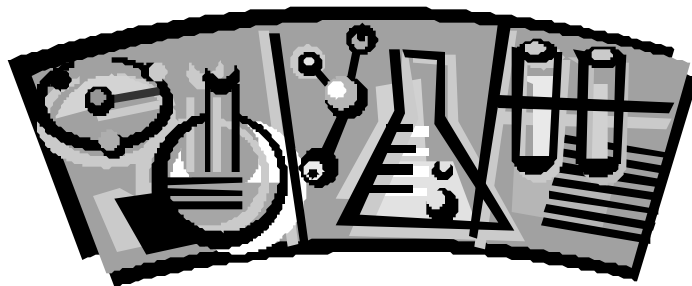

WORKSHOPS TO BE HELD AT THE 2004 ANNUAL MEETING

CAPILLARY ELECTROPHORESIS IN DNA ANALYSIS

At the 2004 Annual meeting, NEAFS will be sponsoring a 2-day workshop on the uses of capillary electrophoresis for STR analysis. Topics will include the physics and chemistry involved in C.E separations, as well as how currently available software determines fragment sizes and allele designation.
